If the claim is for the death, all documents from a licensed veterinarian, a formal necropsy, and cause of death will be sent to the  ler including microchip verification. If the claim occurs within the first year and the claim is valid, the puppy will be replaced with one of  valid value and of the same gender as puppies are available, with the Buyer being responsible for all transportation costs. Prior to  lacement of the puppy, the original AKC papers must be signed and returned to the Seller.
